The Yukon Micro Loan Program is a tiered lending program—starting at \$3,000 for a first loan—to individuals who want to start, maintain or expand small businesses. Loan terms range from three months to three years. Applicants who successfully repay their first micro loan can apply for gradually higher amounts of funding for a future loan (maximum \$12,000 for a fourth loan). Additionally, those who repay their loans in a timely fashion may qualify for interest rate reductions on subsequent loans. Unlike other loan programs, the Yukon Micro Loan Program focuses on the applicant's character, trustworthiness and personal commitment rather than on the applicant's credit history and amount of collateral. In this way, the Yukon Micro Loan Program makes funds available to entrepreneurs who might not qualify for larger amounts of financing under more traditional loan programs. Micro loans can help an individual establish credit or improve a poor credit history. Micro loans can be used for business purposes such as: Buying or leasing equipment, tools or computers Making leasehold improvements Purchasing craft materials, supplies and inventory Paying first and last month's rent on a commercial space Advertising Micro loans cannot be used to refinance existing loans or to pay off personal debt. 4097 CAPITAL RECREATION FUNDING PROGRAM

Unincorporated communities can apply annually to the Small Capital Projects Fund. The funding can be used to cover up to 100% of a project, up to a maximum of \$20,000 per community. Applications will be reviewed and prioritized as they are received. Projects may include repairs and upgrades to existing recreation facilities (non-YG owned buildings only) and small capital projects, as well as the purchase of functional equipment (printer, fridge) or furniture which are necessary for the operation of the facility. Work identified as high urgency are those affecting health and safety concerns, structural integrity, protection of property, end of life span and will be given highest priority...
